MINUTES

1. Attendance:

Councillors: Peter Hellier (PH - Chair), John Mallone (JM), James Everett (JE), George Ford (GF).

- 2. Apologies: Councillors Ingrid Wilms (IW), Peter Rendle (PR).
- Approval of minutes of meetings: The minutes of the meeting held on 1st July 2025 were reviewed and approved. Proposed by JM and 2nd by JE. Motion carried.
- 4. Public Participation:
 - a. An accident has occurred at the church this week and resulted in one of the people installing the bells, falling through the belfry. JE would like to propose that we donate something to the air ambulance and PH suggested this be added to the agenda for the September meeting.
 - Bristol airport —a resident noticed that when there is a westerly wind there can be a strong smell of aviation fuel coming from Bristol Airport.
 - c. A resident has noticed increased traffic flow through Nempnett Thrubwell. AB advised that 2 accidents had occurred on the Chew Valley road and this was closed due to a fatality. In addition, the high street is temporarily closed in Chew Magna compounding the problem.
 - d. SLOW signs need to be replaced to the tarmac where a new road surface has been added and SLOW sign was covered up.
 - e. A resident suggested that 20mph limits should be applied to all lanes through Nempnett Thrubwell.

ACTION: LH to find emails previously sent to highways regarding 20mph limits and forward to AB.

ACTION: LH to request SLOW be re-painted on new road surface

- 5. Declarations of Interest:
 - a. There were no declarations made by Councillors.
- 6. Ward councillors update:
 - a. Persistent anti-social driving issues are being experienced through the Chew Valley throughout this summer, especially around Chew Valley Lake via Cheddar. Meetings have taken place with the police and residents have complained and raised their concerns. The recent fatality is possibly the result of this anti-social behaviour.
 - b. Local Plan re: new homes- this does not affect Nempnett Thrubwell.

- c. The consultation process and the opportunity to make changes to local planning regulations starts in September. All councillors and residents are encouraged to pass on their comments and suggestions.
- d. AB asked what the main employment was in NT. The Chair suggested management roles.

7. Highways -

a. Cameras for Pit Lane – PH reviewed the report written by IW re the types of cameras and prices plus the legality of erecting a camera and reasons for recording as caution and guidance is needed around GDPR. All agreed that this will be reviewed again at the September meeting.

ACTION: IW to update at the September meeting.

b. Hedge at junction of Pit lane and Five ways overhanging the road- IW visited this site to review the drains and look at a site for a possible camera. PH also visited the site to speak to the resident but there has been no progress with overhanging hedges.

ACTION: LH to contact highways to report the overhanging hedges and that the verge needs to be cleared back to uncover the full extent of the tarmac at the corner. 2 members of the PC have spoken to the residents but that the hedge was still overhanging the highway.
